## **Khan Provides Update on Settlement of its Dispute with the Government of Mongolia**

**TORONTO, ONTARIO, Canada, March 16, 2016** – Khan Resources Inc. (“**Khan**” or the “**Company**”) (CSE: KRI) announces that it has received a notice of discontinuance from the Paris Court of Appeal that the annulment proceedings initiated by the Government of Mongolia against the international arbitration award rendered in favour of Khan are now terminated. The Company also wishes to announce that proceedings in the US District Court for recognition of the award have now been stayed pending receipt of the settlement amount of \$US70 million.

Mr. Grant Edey, President and CEO of Khan, commented “Khan and the Government of Mongolia are continuing to progress in good faith towards the receipt of the settlement amount on May 15, 2016”.
